

# EPPA Update 02-01

## CONCORDANCE FOR REVISED STATUTE

Notice to Users of *Employment Pension Plans Act and Regulation*:  
In January, the *Employment Pension Plans Act*, RSA 2000, Ch. E-8, replaced the *Employment Pension Plans Act*, Ch. E-10.05, with the adoption of the Revised Statutes of Alberta 2000. There were no substantive changes to the Act, but all the section numbers changed. As a result, where the Employment Pension Plans Regulation (A.R. #35/2000) cites section numbers in the Act, those section numbers no longer correspond to the correct sections of the legislation. An amendment Regulation is being prepared that will update all the Act citations, but in the meantime, readers of the Regulation should consult this excerpt from the Concordance to the Act to determine the correct citation.

All the Public Acts forming the Revised Statutes of Alberta 2000 have been given new chapter numbers and most provisions have been renumbered. This Table is intended only as a guide to assist the user in relating the statutory provisions as they existed on December 31, 2000 to the corresponding provisions in the Revised Statutes 2000.

The left-hand column shows the Acts as of December 31, 2000 and the centre column shows the corresponding Acts included in the Revised Statutes of Alberta 2000. The "Remarks" column indicates whether certain provisions were repealed by the revision (Rep. by Revision) or omitted from the revision but not repealed (OBNR).

**MEANING OF THE TERM IN "REMARKS" COLUMN**

- **Rep. by Revision** - enactment has been omitted from and repealed by the revision
